AKRIDGE NAMED FIRM OF THE YEAR AND THE STACKS AWARDED **BEST REAL ESTATE TRANSACTION – SALE OR RECAPITALIZATION OVER \$25 MILLION**

(Washington, D.C.) — NAIOP DC | MD honored Akridge and its partners with two awards at its annual Awards of Excellence event on October 11, 2023. Akridge was recognized as the Firm of the Year for its remarkable contributions in both the real estate industry and the Washington, DC community. Additionally, Akridge and its partner National Real Estate Development were awarded the Best Rest Estate Transaction – Sale or Recapitalization over \$25 Million for The Stacks development in Buzzard Point. This marked a record-breaking deal in the District and the largest opportunity zone equity deal in the metro area. The transformative project will redefine residential living along DC's Southwest Waterfront. The first phase, totaling 1.15 million square feet, encompasses over 1,100 multifamily units, 43,000 square feet of retail, co-working office spaces, and a site designated for future hotel development.
