It leverages guidance from the IWBI Task Force on COVID-19 and incorporates recommendations from reputable organizations such as the World Health Organization (WHO), U.S. Centers for Disease Control and Prevention (CDC), global disease control and prevention centers, and emergency management agencies. Additionally, the rating draws from recognized standard-making associations like ASTM International and ASHRAE, as well as leading academic and research institutions. The core principles of the rating

are derived from IWBI's WELL Building Standard, which is the premier framework for advancing health in buildings and spaces of all types.
